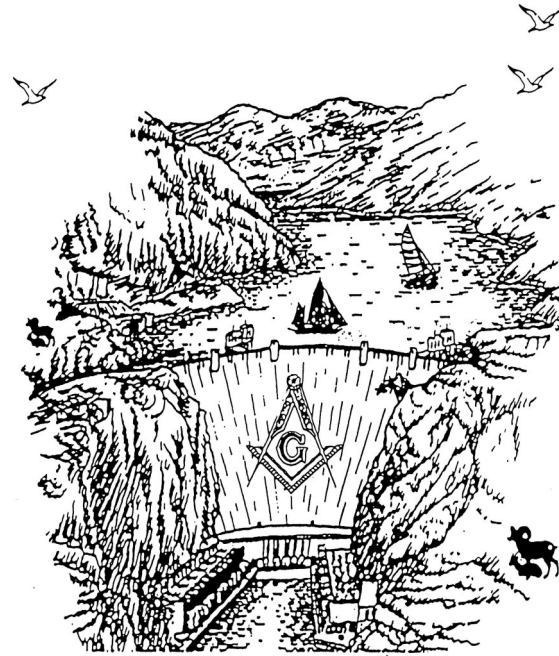

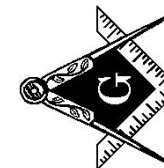

Brothers, Greetings Brothers, and welcome to cooler weather. Join us before the Stated Communication and enjoy some KFC in honor of fellow Mason Harland David "Colonel" Sanders. In other Masonic history, In 1839 the Mormons left Missouri and settled in the area of Nauvoo, IL. On October 15, 1841, the IL Grand Master issued a dispensation to form a lodge at Nauvoo. On March 15th, 1842, Joseph Smith received his first degree and the others shortly after. Certain irregularities were reported – in five months the lodge initiated 256 candidates and 243 were raised. After investigation, the Grand Master revoked the dispensation, but the lodge continued to work. On April 5, 1844, the Mormon masons dedicated a Masonic Temple. IL Masons got in trouble for taking part in the ceremony. Opposition to the group and internal dissension led to the assassination of Joseph Smith and the removal of the Mormons from IL. See you in Lodge.
